



# HOME STUDY ONLINE BAR REVIEW

The Fleming's Fundamentals of Law (FFOL) **ONLINE** Bar Review is a home study program for those who cannot attend the live lectures. This program combines the benefits of the FFOL live course with the advantage of studying at home, at work, or wherever you choose. All lectures are digitally recorded live for online streaming via the Internet, and are hosted through the Blackboard educational service.

As an online student, you receive the identical essay and performance writing assignments as those attending the live program. The course includes MBE assignments for each MBE subject. **A:** The Home Study Online Bar Review allows you to begin studying at any time. You may begin studying as early as 4½ months prior to the Bar examination. This gives you a full week to learn the substantive law in each subject. After you complete all of the substantive law lectures according to the schedule, you proceed to an **FFOL Boot Camp** schedule that allows you to fine-tune and test take 30 days prior to the exam without the pressure of having to learn new information. Also, you can listen to the lectures as many times as you want or go to a specific area of law you want to review as each lecture is conveniently separated into tracks for easy navigation.
