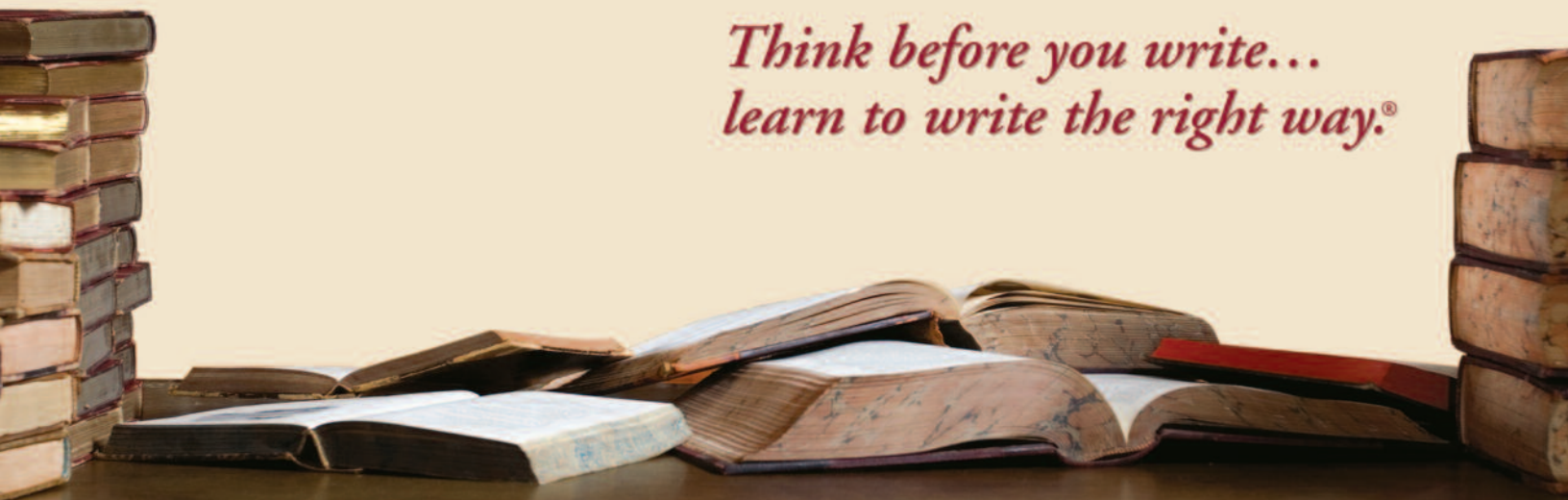

The Legal Examination

The Legal Examination Writing Workshop is designed to teach law students how to Analyze, Organize and Write a Superior Law School Examination.

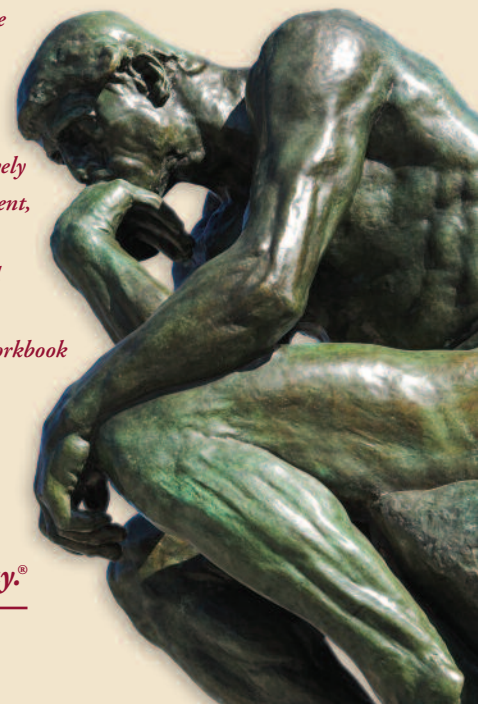
